Alberta After-death Documentation Pathway for Next of Kin

Medical Certificate of Death (MCD)



Completed by MD (if person was under care) or Medical Examiner (if person was without MD, or died under unwitnessed or suspicious circumstances). In this case, the body may or may not be transported to Examiner's office and an autopsy may or may not be performed.

Registration of Death



Take the MCD to the Vital Statistics Division in admitting dept. of your local hospital or at any AB registry office.

Death Certificate

Vital statistics creates this & the executor/eligible person can order this from a registry agent once death has been registered. Many orgs require this before decisions can be made re. estate of the deceased.

Burial Permit

Issued by Vital Statistics Dept at hospital or any AB registry office, at the same time that the death is registered. You will need to keep the Burial Permit with the body during transportation to the cemetery or crematorium.

Form 4

Required to transport a body out of the province. To obtain one, fax a copy of the MCD to the Medical Examiners' office with deceased's name, DOB and that the request is for transport. Inquire about a Zeigler Shipping Case to avoid embalming if you are traveling by plane.

Legalities to Consider - Families Transporting Bodies Themselves

Cremation
No legislation in AB requiring casket to be used in cremation, but if they are to store the body, a crematorium will request deceased to be enclosed in a combustible, rigid, leak-proof container with handles. Check with the facility to ensure your container meets their requirements.

Burial / Entombment
Cemetery operators need advanced notice of the burial and will have fees and contract for you to sign. You need to ensure if you are providing your own casket that it meets with their cemetery by-laws.
